- LGIP – Local Government Investment Pool; the CD that matures in February will be rolled into the checking account and then enough to make 30,000 will be placed into the Poo.
- Guidelines for Government shutdown for the policy and procedure book was reviewed there are some things that do not apply here or are not needed. The information will be adjusted for presentation to the board.
- Workshop for January 27th was mentioned, Minidoka will sponsor 8 students and advisors from Minico.
