VI. New Business

1. AIS Cotterell Station Update: Betty Carlson shared the station is getting very busy with inspections and hot washes. ISDA has sent the contract to Cassia County. Jordan Searle has followed up to see if they are going to sign the MOU. The West Cassia Board agreed to wait until the end of June 2025 to see if Cassia County will sign the MOU. If they will not sign West Cassia would like to ask ISDA to check with ISP about modifying their MOU to take more shifts. Betty has been keeping track of drive-bys and returns. Rachelle Osterhout shared the rudder was broken on a kayak. The owner would like to be reimbursed for the replacement; the cost is \$15.90. The owner filled out a tort claim paper and provided a copy of the receipt for the new rudder. The inspectors also provided pictures and they provided statements. Ken Black made the motion to reimburse the owner the amount it cost to replace the rudder (\$15.90). Chad Searle seconded the motion. Motion Carried.

2. Natural Resource Camp:

- East Cassia SWCD: Board members discussed Natural Resource Camp Scholarship amounts and would like to encourage more students to attend. <u>Kurt</u> <u>Heward made the motion to increase the NRC budget amount from \$100 to \$600</u> <u>which should pay full camp tuition for 2 students. Ken Woodworth seconded the</u> motion. Motion carried.
- West Cassia SWCD: Doreen shared that the cost to attend the Natural Resource Camp was \$280 per student. 2 students from West Cassia attended the camp this year. West Cassia reviewed the budget and the decision was made to increase the amount to cover the 2 students who attend the camp.

3. FY2025 Budget Review/ Approval of Amendments:

- West Cassia SWCD- Supervisors reviewed the proposed FY26 Budget. Chad Searle made the motion to accept the FY26 budget as presented. Ken Blacked seconded the motion. Motion carried.
