LESSEE agrees to use the Direct Seed Drill in a careful and prudent manner on fields that are appropriate for use and to return it in the same or better condition as received; normal wear from responsible used is expected. LESSEE agrees not to use field run seed, as it can damage the drill or plug up the drill and cause added expense to clean out the drill. LESSEE shall be responsible for loss, theft, damage, or destruction of Direct Seed Drill and all liability for its use and transportation, beginning from the time it is checked out from the District until such time as it is returned to the District. See operator manual (upon request from office) for maximum drilling speed and transport speed. Adjust for rough road conditions.

DISENGAGE DRIVE WHEEL BEFORE TRANSPORT. Failure to comply with these terms and conditions will result in LESSEE being charged for all repairs at current shop rate for said repairs.

For those who rent the Direct seed or No-Till Drill this page is a condensed version of the contract you signed. Along with a brief checklist for maintenance and phone numbers to contact with any concerns.

RENTAL LESSEE shall pay to the renting Soil and Water Conservation District the rental sum of **\$15.00** per acre and **\$75.00** per day for the use of the Direct Seed or No-Till Drill. Payment is due within 30 day of date of billing. There will be a 1.5% late fee for amounts not paid within the 30 days.

TERMS AND CONDITIONS The Direct seed or No-Till Drill equipment is used at LESSEE'S sole risk. LESSEE agrees to use the Direct seed or No-Till Drill in a careful and prudent manner on fields that are appropriate for use. (i.e. cropland that has been in productions within 2-years of rental **NO SAGE BRUSH**) and to return it in the same or better condition as received. LESSEE agrees to NOT use field run seed, as this can damage the Drill or plug up the drill and cause added expense to clean out the drill at LESSEE's expense. LESSEE shall be responsible for loss, theft, damage, or destruction of the Direct seed or No-Till Drill and all liability for its use and transportation, beginning from the time it is checked out from the renting District until such time it is. Returned to the District.

<u>Disengage</u> drive wheel before driving/transporting. Failure to comply with these terms and conditions will result in LESSEE being charged for any and all repairs at the current shop rate for repairs.

NOTIFICATION LESSEE shall notify the renting District if the equipment is in need of maintenance or repair.
